**CALL LETTER FOR ONLINE PROVISIONAL ADMISSION
TO SAINIK SCHOOL, JHUNJHUNU

Dear Parents,

2. Keeping in view Nationwide lockdown in the country due to COVID-19, online provisional admission will be given to your son/ ward subject to online submission of mandatory admission documents and deposit of fee. Candidate who is given provisional admission will be called for admission/ joining the school when the school re-opens after COVID-19 crisis as per Central/State Govt guidelines.

3. Submission of Mandatory Documents through online as given in **Appendix 'A' (Admission documents)**. The documents from **Ser No. 01 of Annexure-XI** are **mandatory requirement for grant of provisional admission**. Last date for submission of online documents is **09 Sep 2020**. The documents are required to be submitted through email "sainikschooljhunjhunu@gmail.com" (properly scanned in PDF format). Incomplete ineligible documents will not be accepted. In case of any doubt/ query, the same may be resolved on Mob No. **9509941973** between **10.00 AM to 01.00 PM** on all working days. **Original copy would be required at the time of joining of school. The provisional admission would be confirmed on verification from concerned Govt department.**

4. **Payment of online Fee.** After submission of documents by the parents as mentioned at Para 3 above, these will be scrutinized by this school and the candidate. Parents will be informed about acceptance of documents. After receiving the acceptance of admission, fees is to be deposited as given through RTGS/NEFT using bank account as mentioned at Para 5. **It is reiterated that the fee will be deposited only after intimation from the School E-Mail/SMS/Website.** Total fees for new admission is **Rs 1,42,000/- (Rupees One Lakh forty two thousand Only)** for General/ Defence Candidates and **Rs. 1,40,500.00 (Rupees One lakh forty thousand five hundred only)** for **SC/ST** Candidates. The fee is required to be deposited in two installments considering financial

6. Once the fee is credited in the school account, the candidate will be given provisional admission in the school and the same will be intimated to the parents through email/ SMS. Physical receipt for fee can be obtained from the School at the time of joining of the cadets.

7. **Online Classes due to COVID-19 (Important)**. On provisional admission in the school, the cadet will be allowed to join online classes for which the parents would have to intimate their WhatsApp No.

8. **Final Admission/ Joining the School**. As all are aware that the schools are closed due to COVID-19, the same will reopen as per directions from the Central/ State Govt/ Sainik School Society. Accordingly final date of admission/ joining dates of new entrants will be decided by the School and the same will be intimated to the parents through email/School website www.ssjhunjhunu.com/SMS.

9. **Documents/ Items required at the time of Final Admission/ Joining of the School**. In addition to the documents (in original) mentioned at Para 3 above, the documents mentioned at Ser No. 02 to 03 of **Annexure-XI** are also required at the time of final admission/ Joining the School.

10. Please note that **admission/ Provisional Admission of your ward may be cancelled in case any of the document mentioned at Para 3 are not submitted within the stipulated time or if any documents is found false/ incomplete at later stage.**

11. No Scholarship/Subsidy/Assistance will be adjusted as advance against fees payable to the school and full fee will be paid as indicated above at time of admission and subsequent installments (subject to review). On award of the Scholarship and Subsidy by State Govt/Ministry of Defence (based on complete scholarship documents submitted by the parents at the time of admission), the same will be adjusted against the fee paid only on receipt of scholarship.

Documents mentioned at serial number 1(a) to (p) of the **Annexure-XI** are mandatory at the time of admission. The original documents are to be produced for verification. In case any document mentioned at serial number 2 & 3 of Annexure XI is incomplete, the same will be required to be completed within **10 (Ten)** days from the date of admission. Admission will be given only on provisional basis till submission of all documents in original. Candidature is subject to be cancelled due to non-submission of original documents as required.

13. List of Clothing items and others Articles required to be brought by the candidate at time of admission is attached as **Annexure-X**.

14. Please note that the candidate will be admitted to the School **ONLY** on fulfilling the following conditions:-

(a) Submission of all documents completed in all respects as mentioned at **Appendix- XI** to this letter.

(b) Submission of Fees (Online) **Rs 1,42,000/- (Rupees One Lakh forty two thousand Only)** for General/ Defence Candidates and **Rs. 1,40,500.00 (Rupees One lakh forty thousand five hundred only)** for SC/ST Candidates towards annual fees is required to be deposited in two installments considering financial hardship of the all parents due to COVID-19. The details of the fees installments (two) are as follows:-

16. **Any kind of wrong/ false Declaration, information, Discrepancy furnished by the Parents at the time of admission of their wards or at on later stage which will prove as wrong/ false then candidature/ admission will lead to cancellation .**

17. Jurisdiction Authority is District Court Jhunjhunu only, in case of any legal issues.

18. Carrying of costly items, Cell Phone, contrabands, eatables or hard cash/ currency by the candidates/ students will not be permitted in the School and the same will also not be tolerated if it is sent through Post/courier any other means. If any child is found in possession of the banned items mentioned above, he will liable for severe action/ penalty as well as the items will be confiscated.
